The Matter of the Dissolution of the  
Central Lakes Region Sanitary District

**Resolution D-2009-11, to Assign  
Easements to Leaf Valley  
Township, Douglas County,  
Minnesota**

---

Director Vollmers moved adoption of the following resolution:

**Whereas**, the Central Lakes Region Sanitary District (CLRSD) holds permanent and temporary easements, both recorded and unrecorded, for the construction of a sanitary sewer system;

**Whereas**, CLRSD adopted its Resolution of Intent to Dissolve at its regular meeting on March 5, 2009;

**Whereas**, the CLRSD adopted its Resolution D-2009-05, Directing Coordination and Disposition of Easements on April 2, 2009; and

**Whereas**, the attorney complied with Resolution D-2009-5 by sending correspondence to the Douglas County Board of Commissioners; the Boards of Supervisors of Carlos, Miltona, Leaf Valley, Moe and LaGrand Townships; the City Councils of the Cities of Miltona and Carlos; and the Board of the Alexandria Lakes Area Sanitary District soliciting interest in the easements, describing the public investment in the acquisition of the easements, and requesting a response by April 30, 2009.

**Whereas**, by April 30, 2009, only Moe, Leaf Valley and Miltona Townships have expressed an interest in succeeding the CLRSD in the easements, and

**Whereas**, by resolution 2009-08 the CLRSD Board directed its attorney to:

1. Continue to work with Moe, Leaf Valley and Miltona Townships to resolve any issues regarding succession of interest in the easements within Moe, Leaf Valley and Miltona Townships.
2. As to the remaining easement interests, and if Moe, Leaf Valley or Miltona Townships decide not to become a successor in interest, prepare for execution and filing instruments to vacate all easements not otherwise transferred.
3. Coordinate all procedures required by law to facilitate the transfer or vacation of easements; and

Whereas, on May 12, 2009 the attorney corresponded with Moe, Leaf Valley and Milona Townships setting forth the requirements for transfer; and

**Whereas**, CLRSD received a request from the Leaf Valley Township Board for the assignment of CLRSD's interests in the easements to the Township; and

**Whereas**, CLRSD Board has determined that it is necessary, and is in the best interest of CLRSD and its residents, to assign CLRSD's interests in easements located in Leaf Valley Township to Leaf Valley Township; and

**Whereas**, the Notice of the Resolution of Intent to Dissolve has been perfected.


**Therefore, it is resolved:**

1. The Board of Directors of the CLRSD shall assign any and all of CLRSD's rights, recorded and unrecorded, in easements for property located in Leaf Valley Township to Leaf Valley Township.
2. The Board Chairman and Secretary are directed to execute this Resolution, along with the easement assignment document prepared by legal counsel identifying specific legal descriptions of the assigned easements, and record both documents with the Douglas County Recorder.
3. The assignment of the easements shall be effective immediately.

The motion was seconded by Director Thoennes. After discussion and upon a vote, the Resolution was adopted by the following vote:
